### **Competition Rules:**

The contestants will perform their “Model Walk” (personal preference) to the center of the stage, stop and do a front stance, stop, do a full turn to do a rear stance, turn to the front again, then proceed to the side of the stage. The contestants will wear high heels and a two-piece swimsuit of their choice, provided that no thong suits will be permitted. Jewelry may be worn in this round. No oil may be worn.

**Comparison:** The contestants will present their full front and rear stance with other contestants wearing their two-piece swimsuits and high heels. Judges will score competitors on “Balance and Shape” and overall physical appearance, including complexion, skin tone, poise and overall presentation.

**Finals:** The top five (5) competitors in each height class will receive trophies.
