**Round 1/Swimsuit:** The contestants will present quarter turns with other contestants, wearing high heels and a two piece swimsuit of their choice, provided that no thong suits will be permitted. Jewelry may be worn in this round. No oil may be worn. Elimination rounds may be necessary in the round, depending on the number of contestants.

**Final Assessment:** All competitors will be brought back in their two-piece suits for quarter-turns. The top 5 will then be re-scored and those scores will be added to the prejudging scores for a final score.
